## New Plymouth City Council Meeting TUESDAY 6 February 2012 7:00 p.m. New Plymouth City Council Chambers (Library)

On the 6<sup>th</sup> of February 2012 the city council meeting was called to order at 7:00 pm by Mayor Joe Cook. Roll call was taken with council members Mayer, Warnke and Esplin in attendance. Councilman York was not able to attend.
