The Council asked that Andy request more pictures of the fixtures completely installed by the next Council meeting. City Attorney Dan Chadwick said we should go with Andy's recommendation and proceed with 40% payment. With the SW Sewer Project, Andy reviewed the payment application and has recommended approval of payment.
