- c. Zone Change Vacant Lot-Cypress Group Industrial to Commercial-Councilwoman Balcer voiced a concern with the bridge and the ability to withstand the added traffic with the Family Dollar Store. Councilman Warnke advised that they are alternate routes available that don't include the use of the bridge. Superintendent Beau Ziemer said that with their building permits and right of way permits that will be addresses.

### Industrial to Commercial. Councilwoman Kurth seconded the motion. Motion carried.

d. New City Hall Remodel Design- Discussion was held between the Council and City Clerk Danielle Painter, City Engineer Andy Gehrke, & Superintendent Beau Ziemer regarding the lay out of the Council room. Councilwoman Balcer asked if there was a reason why the chambers were being set up the way they were in the current plans. City Engineer Andy Gehrke explained that to be in compliance with the ADA there was not another option for the lay out. Andy Gehrke also pointed out the fire rated construction of the records vault. Danielle Painter let the Council know that before the move there will be work done on retention of records. That way we will only be moving what is required to be kept. Mayor York asked that this decision be tabled until all the council members can be present to make a decision.

Councilwoman Balcer made a motion to table this item until the 2<sup>nd</sup> meeting in January. Motion died for lack of a second.
