Opening statement given by Snowball 7.0 LLC attorney Brad Crockett 12209 E Mission Ave Suite 5, Spokane Valley, WA 99206 Brad Crockett addressed the council on behalf of his clients Snowball. They are requesting 3 parcels for zone changes. This will allow the mill to continue to operate safely & effectively. If they aren't allowed the zone changes, they will unfortunately have to relocate out of New Plymouth. The current residential property at 147 SE Blvd will be used for mostly storage of lumber which will give them more area to operate on the other two parcels. They have added additional shifts which offers more employment opportunities. They have raised wages & have added benefits as well as a 401 K program. They are working on moving more of the operations indoors which will help on the noise. They have made several improvements to the property and will continue to do so. They are adhering to the noise decibels per operating hours of city code.

- c. Zone Change 418 SE Ave (Action Item)
 Councilman Warnke made a motion to grant the zone change for 418 SE Ave from Commercial to Industrial. Councilwoman Balcer seconded the motion. Roll call vote. Councilman Warnke, yes.
 Councilwoman Kurth, yes. Councilwoman Balcer, yes. 3 yeses. Motion carried.
- d. Spring Clean-Up Dates (Action Item)
 Councilwoman Balcer made a motion to set the spring clean up dates for 3/28/2022-4/25/2022 with an alternate start date of 4/4/2022-5/02/2022 depending on dumpster availability. Councilwoman Kurth seconded the motion. Motion carried.
- e. City Council Appointment (Action Item) Mayor York announced the candidate for the city council appointment, introducing Heather Airoldi 110 SE Blvd NP. The council asked some questions of the

candidate. Heather addressed the council & said she was looking forward to serving the community by being a councilwoman.

Councilwoman Balcer made a motion to accept the appointment of Heather Airoldi to the city council of New Plymouth. Councilwoman Kurth seconded the motion. Roll call vote. Councilman Warnke, yes. Councilwoman Kurth, yes. Councilwoman Balcer, yes. 3 yeses. Motion carried

a. Engineer's Status Report- Beau reports that the tank coating is going well. They're sandblasting during the day. So far there has been no complaints about the water.

Mayor & Council Comments

Councilwoman Balcer asked when the road work will start at Harvest Creek. Beau said there was too much mud which is why it's taking a little longer to start. Andy Gehrke has requested an official meeting with Harvest Creek. They haven't heard back from them yet. The curb & gutter have to be completed before the street can be paved. Councilwoman Balcer asked that if we haven't heard back from them by the next council meeting, we want the developer here in front of the council.
