New Plymouth City Council Chambers

On the 21ST of February 2023, the New Plymouth City Council meeting was called to order at 5:58 P.M. by Mayor Rick York.

The pledge of allegiance was led by Jim Lacrone.

Roll call was taken with council members Heather Airoldi, Cora Kurth, Eileen Balcer, Bill Warnke and Mayor York present.

February 6, 2023, City Council Minutes- Action Item

Councilwoman Balcer made a motion to approve the minutes from February 21, 2023, with the corrections discussed. Councilwoman Airoldi seconded the motion. Motion carried.

Claim Approvals- Action Item

Councilwoman Kurth made a motion to approve the claim approvals totalling \$35,256.40. Councilwoman Airoldi seconded the motion. Motion carried.

<u>Public Hearing Hampton's Subdivision Preliminary Plat, Zone Change & Development Agreement-Open Public Hearing 6:00 p.m.</u>

David Bailey, Bailey Engineering 1119 E State St Eagle ID. Mr. Bailey representing Trilogy Development spoke to the council regarding the Hampton Subdivision. They are asking for the zone change from Res A to Res B which will allow them to build on the proposed 27 lots. This property is already in city limits on the northeast side of the city. The average lot size for the subdivision will be 9700 square feet with an open space dual use area for draining and public space. The zone change will be accompanied with a development agreement. Mr. Bailey wanted to address some of the questions from the P&Z meeting. They have a letter from the irrigation company stating they have met all the requirements for irrigation. They will also be adding additional piping to the current system. David Sotutu updated the numbers for the school district, there is room for this growth. Public Works has confirmed that the current water/sewer system is able to handle the capacity of this new subdivision. Power/gas has been approved as well. The current development agreement has all the information that is needed for a complete successful build. The plat consists of only single-family homes, there are no duplexes.

- e. Idaho Facility Grant- Melanie Cope (Action Item) Melanie explained the Idaho Facility Grant to the council. The grant amount is anywhere from \$5000.00 to \$500,000.00. The first letter asking to be a part of this grant is due within 6 days. If awarded any grant funding the project must be completed by August 2026. The decision on which building to use the grant funds on needs to be made by the council.

Councilwoman Balcer made a motion to send out the grant letter of intent and for the funds to be awarded to the new building. Councilwoman Kurth seconded the motion.
