HARDIN SANITATION RATE INCREASE - ACTION ITEM

Mark Fulwiler, with Hardin Sanitation, was present to request a 2.6% increase for both residential and commercial service, effective July 1, 2018. Councilman Hoppell moved to approve the Hardin Sanitation Rate Increase. Councilman York seconded the motion. Motion carried.

PAYETTE COUNTY SHERIFF CONTRACT RENEWAL - ACTION ITEM

The Payette County Sheriff's Office requested an increase in dispatch fees for the Fiscal Year 2018-2019. The increase would be from \$4,730.37 to \$9,896.75, which is determined by the formula outlined in the Intergovernmental Agreement approved June 2017. Councilman York moved to approve the Payette County Sheriff Contract Renewal. Councilman Hoppell seconded the motion. Motion carried.

IDAHO GEM GRANT - TOM HOPPELL - ACTION ITEM

The council decided to add a drinking fountain, chase doors and a lock system to the bathrooms for the Idaho Gem Grant application. Councilman Warnke moved to approve the statement of contribution of \$13,362 plus the price of the 3 items added by the council. Councilman York seconded the motion. Motion carried.
