On the 19th of March 2018, the New Plymouth City Council meeting was called to order at 6:00 PM by Mayor Earles. The Pledge of Allegiance was led by Councilwoman Balcer. Roll call was taken with council members Tom Hoppell, Bill Warnke, Eileen Balcer, and Rick York in attendance.
