Regular Agenda – Councilman Warnke moved to approve regular agenda. Councilman York seconded the motion. The voting was unanimous in favor of the motion.

Consent Agenda – The consent agenda included 7 December 2015 Council Meeting Minutes, Payette County Sheriff's Report, and Claim Approvals totaling \$19,636.62. Councilwoman Kurth moved to approve consent agenda. Councilman York seconded the motion. The voting was unanimous in favor of the motion.

Write-off account balance for a deceased patron – Danielle Painter, City Clerk informed the City Council of the information we received from the collection bureau regarding account number 419-02. Collection bureau cancelled the account on their end, because the patron had passed away. **Councilman York moved to approve that this account be written off, Councilwoman Mayer seconded the motion. The voting was unanimous in favor of the motion.** 

## Ordinances and Resolutions

<u>Ordinance #347</u> - "An ordinance of the City of New Plymouth, Idaho, vacating certain property; retaining all easements and all other rights pertaining to the realty; describing the property abandoned; repealer; severability; effective date." Councilwoman Mayer moved to read Ordinance #347 by title, and suspend all other readings. Councilman York seconded the motion. The voting was unanimous in favor of the motion. Councilwoman Mayer read the ordinance by title, and the City Council was approached by Beau Ziemer, Public Works Superintendent. Beau updated the City Council on this ordinance and gave them a quick refresher of the ordinance once more. Councilwoman Mayer moved to approve the ordinance, Councilman York seconded the motion. Roll call vote was taken, Mayer – Yes; Warnke – Yes; Kurth – Yes; York – Yes; the record shows 4 yays and 0 nays.

<u>Resolution 2015-04</u> – "A resolution of the Mayor and City Council of the City of New Plymouth, making certain findings and consenting to the annexating of the area within the city into the New Plymouth Fire Protection District; consenting to the legal description of the amended fire district boundaries; directing the City Clerk; making a request to the Commissioners of Payette County; and providing an effective date." Councilwoman Mayer moved to approve and read Resolution 2015-04 by title, and suspend all other readings. Councilman Warnke seconded the motion. Roll call vote was taken, Mayer – Yes; Warnke – Yes; Kurth – Yes; York – Yes; the record shows that Resolution 2015-04 passed by 4 yays and 0 nays.

Councilman Warnke commented on how hard the public work's employees worked when it snowed, he commends them on their great job.
