Alta Mesa Technical Review from Payette County P&Z and Review Comments from Beau Ziemer - Public Works Superintendent Ziemer presented the council with information pertaining to rezone and conditional use permit applications submitted to Payette County Planning & Zoning from Alta Mesa (AM Idaho, LLC) on property adjacent to the city impact zone. He stated that he had attended a technical review meeting regarding these applications and had drafted a letter with recommendations for Payette County P&Z. Public Works Superintendent Ziemer then detailed the recommendations for the council to review and approve.

**Councilman York moved to send a favorable letter to Payette County P&Z with recommendations from Public Works Superintendent Ziemer regarding AM Idaho, LLC. Councilman Warnke seconded the motion. The voting was unanimous in favor of the motion.**
