## New Plymouth City Council Meeting MONDAY 5 June 2017 6:30 P.M. New Plymouth City Council Chambers

On the 5<sup>th</sup> of June 2017, the New Plymouth City Council meeting was called to order at 6:36 P.M. by Mayor Beth Earles. The Pledge of Allegiance was led by Councilman Ron Rouse. Roll call was taken with council members Rick York, Ron Rouse and Cora Kurth in attendance. Councilman Bill Warnke was absent.

# JAN MORRISON – 501 S NILES

Jan Morrison asked the council if there was anything planned for the eclipse happening on August 21<sup>st</sup>, 2017. The eclipse will only be seen for a minute and a half here in New Plymouth compared to 3 to 4 minutes in Weiser and Payette.
