# Public Hearing - Opened at 6:30 PM

JEFF PECK – ZONE CHANGE FROM INDUSTRIAL E TO COMMERCIAL D. COMPREHENSIVE PLAN AMENDMENT FROM INDUSTRIAL E TO COMMERCIAL D FOR 118 W IDAHO STREET.

Jeff Peck presented his application, for a zone change and comprehensive plan amendment form Industrial E to Commercial D, to the council. No public testimony was received.

JEFF PECK – COMPREHENSIVE PLAN AMENDMENT FROM INDUSTRIAL E TO COMMERCIAL D FOR 118 W IDAHO – ACTION ITEM
